## What's the Risk: American Foreign Policy Challenges and Opportunities?

Retired Col. Alan Stolberg, whose 30-year Army career included serving in the national level governmental policy, strategy, and intelligence communities, and as a professor at the U.S. Army War College, will be our speaker April 26 on the topic listed above.

Dr. Stolberg is the current Coordinator for the Department of Defense's Defense Education Enhancement Program and academic advisorsenior mentor for the State Department's African Military Education Program. In these capacities, he helps to coordinate and orchestrate all U.S. government assistance and support for other nations' military educational institutions on a global basis.

In his time as an Army infantry officer, intelligence officer, foreign area specialist for Europe and Eurasia, and a designated strategist, Dr. Stolberg served twice on the staff of the Joint Chiefs of Staff as well as on the staff of the U.S. European Command. He was also Associate Professor of National Security Studies, Henry L. Stimson Chair of Military Studies, and Director of the National Security Policy Program at the War College for 11 years, ending in 2013. He is the author of several publications, including a book, How Nation-States Craft Their National Security Strategy Documents, published in 2012. He is a member of the FPA and currently lives in Mechanicsburg with his wife Dianne.

Born and raised in New York City, Dr. Stolberg earned a bachelor's degree in Political Science from St. John's University, a master's degree in International Relations from the University of Southern California, a master's degree in National Security and Strategic Studies from the U.S. Naval War College, and a doctorate degree in International Relations from Temple University.

Dr. Stolberg is also a graduate of the Armed Forces Staff College, Defense Intelligence College, and the Army's three-year Russia/East Europe Foreign Area Officer Program.
